Today, when the lord Ramlala is worshipped at his place in the grand Shri Ram temple of Ayodhya, the entire humanity is experiencing his glory and aura. Lord Ram belongs to everyone and is kind and generous. May his blessing be upon everyone.

The issue of Shri. Ram Janmabhoomi has been going on for centuries, and this journey has been long and full of struggle. This issue passed through various courts for decades and reached the Supreme Court. The Supreme Court took its much-awaited decision unanimously on November 9, 2019, paving the way for the construction of the lord Shri Ram temple in Ayodhya. Prime Minister Shri Narendra Modi announced the establishment of 'Shri Ram Janmabhoomi Trust' in Parliament on February 5, 2020.
